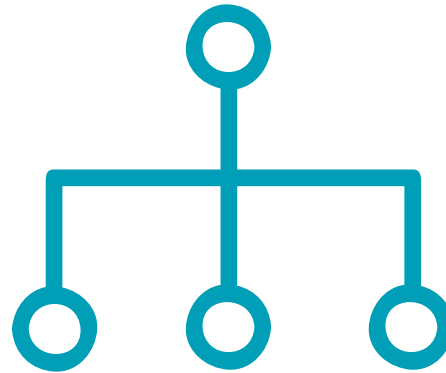

Use the case management register to record tasks such as desk top reviews. Set the priority level and due dates. Quickly identify the number of tasks assigned to an individual and the status of each.

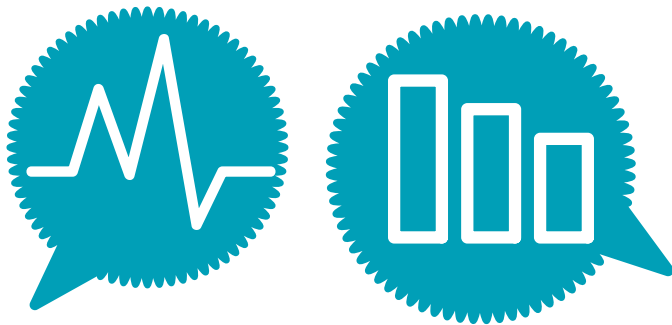

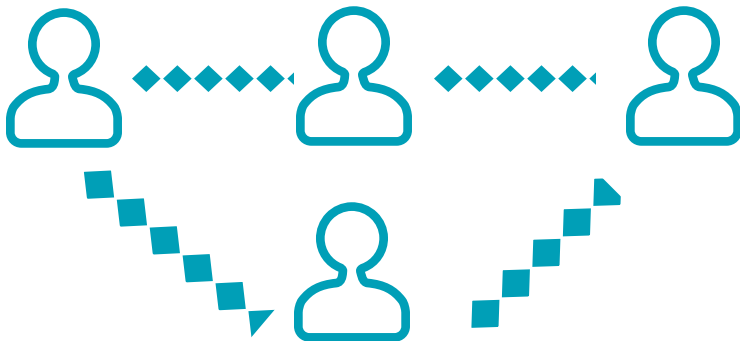

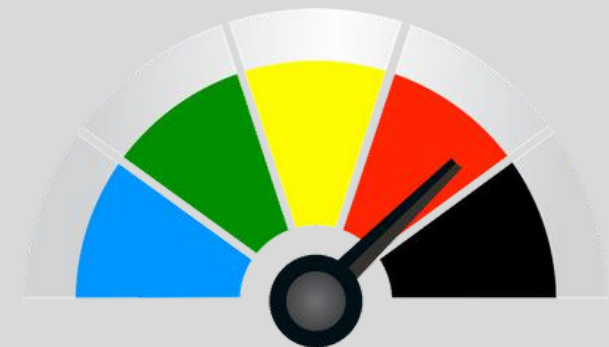
